All properly completed RP-524 forms (Grievance Forms) must be <u>SIGNED</u> by the property owner (part five of the form) and received at the Town via mail or email by <u>8PM ON</u> Grievance Day to be heard. All supporting documents and information that you wish the Board of Assessment Review to consider must be included with your RP-524 form. Property owners will be notified by US POSTAL MAIL of decisions made by the Board of Assessment Review no later than June 30.
